ELIGIBILITY CRITERIA

The main applicant must be 18 years of age and above to qualify for the Citizenship by Investment Program of Antigua and Barbuda. Further applicable requirements are mentioned below:

- Evidence supporting impeccable character
- Excellent health record
- No criminal record
- Sound net financial worth to be eligible to pay for the minimum application fee.

REQUIREMENTS AND PROCEDURES

The application for Antigua and Barbuda Citizenship by Investment Program requires the investor

- Contribute into the National Development Fund (NDF) or
- Invest in an authorized Real Estate project or make a Business Investment.

These crucial conditions are mentioned below in thorough detail



INVESTMENT OPTIONS

A) DONATION TO THE NATIONAL DEVELOPMENT FUND (NDF):

A non-refundable monetary contribution to the National Development Fund (NDF) of at least US\$ 100,000.00 for single applicant.

B) REAL ESTATE:

An investment of at least US\$ 400,000.00 into one of the approved real estate projects is required from investors. The property is to be held for minimum 5 years. The cost of property tax, registration, processing fees must be paid on top of the property value!

C) REAL ESTATE:

An investment of a minimum of US\$ 1.5 Million directly into a qualified business or as a single investor

In case of joint investment involving at least 2 persons, an investment of at least US\$ 5 Million is applicable. Each of those partners must individually invest at least US\$ 400,000.00.

Government Fees

The fees applicable under the program are stated in the table below. 10% of the government fee is payable (and non-refundable) upon submission of an application with the balance due following receipt of an approval letter. A government fee is charged for each family member as prescribed in the list given below. The due diligence fee is charged for each family member above the age of 11 years as prescribed in the table below. The due diligence fee is payable upon submission of the application.

Due Diligence

The due diligence fee, payable upon submission of the application, is charged for each family member above 11 years, as mentioned in the table below-

Main Applicant	USD 7,500
Spouse	USD 7,500
Dependent Child Aged 12-17 Years	USD 2,000
Dependent Child Aged 18-30 Years	USD 4,000
Dependent Parent aged over 55 years	USD 4,000

Passport Fee

Each family member is required to pay the amount prescribed for the Second Passport from Antigua and Barbuda Passport Office.

REQUIRED DOCUMENTS

STEPS TO OBTAIN ANTIGUA CITIZENSHIP

The application process to obtain Antigua and Barbuda citizenship is very simple, taking around 3 to 4 months to complete. It starts with the submission of documents and ends with the issuance of a certificate of naturalization & passport.

Step 1: Eligibility Check

Caribbean Trust ensures eligibility of the applicant, pre-check performed.



Step 2: First Payment

After pre-check approval, transfer the initial payment to start the process.



Step 3: File Submission

The complete file is provided to CBIU for initial background checks, followed by compliance approval and an exhaustive due diligence process.



Step 4: Receive Approval

After the due diligence process, the approval letter is issued by the Antigua & Barbuda government.



Step 5: Final Payment

A formal request is issued whereby you are required to settle the contribution.



Step 6: Receive Certificate of Naturalization & Passport

So, the entire Antigua citizenship process takes about 90 to 120 days to complete, post which the certificate of naturalization and passport issued.

What is the Cost of getting an Antigua and Barbuda Passport?

Antigua and Barbuda have one of the cheapest Citizenship by investment programs. With \$100,000, foreign nationals can get the Antigua passport by contributing to the state fund or investing \$200,000 in real estate.

The Antigua citizenship-by-investment program also allows family members such as your spouse, children, and other dependents.

What are the Antigua and Barbuda Passport Rankings?

The Antigua and Barbuda passport has secured the 30th position on the passport ranking system, a position that sees the Caribbean island as one of the countries in the world with the strongest passport. This means that you can travel visa-free around the world to over 150 countries, including all the Schengen countries, Singapore, the UK, Hong Kong, and more.

The answer is YES! At the rank of 30th place on the passport ranking index, foreign investors holding the Antigua passport can travel visa-free and visa-on-arrival to 150 countries across the world, making it one of the best passports to have.

The good news is, holders of Antigua and Barbuda passports are eligible to apply for the 10-year US B-1/B-2 visa, an easy pathway to the US.
