In August 2013, the Grenada Citizenship by Investment Program was made public. Only the Grenada program in the Caribbean offers visa-free travel to China and the chance to apply for an E-2 USA "Investor Visa" to live there. Those who apply for citizenship in Grenada receive irrevocable citizenship and a passport without having to live there or give up their current nationality.

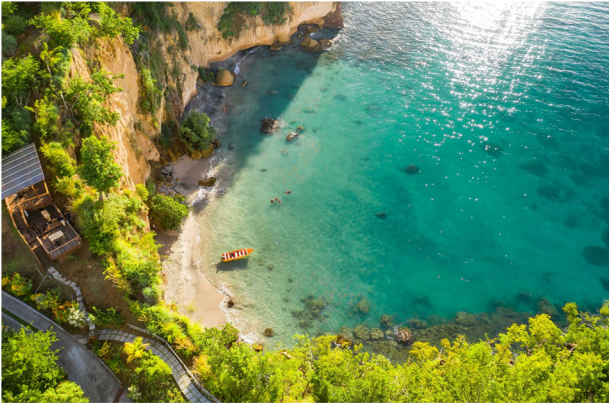

Due Dilligence

Background checks that are required must be paid for by the government, which designates a preferred due diligence organisation. These organisations consult a range of national and local resources, including Interpol, World-Check, and other governmental organisations. These fees must be paid at the time the application is submitted.

- Certified copy of all identity documents/books or cards
- Certified copy of all military service and discharge documents, if applicable (male applicant 18 years and above)
- Twelve (12) Original passport-size photos
- Proof of residential address (certified copy of lease agreement or original utility bill)
- Certified copy of university/college diplomas

Forms and documents required only from the main applicant:

- Approved project sales document – (real estate option only)
- Employment status, wealth, and business affiliates — Form 5
- Investment Confirmation — Form 6
- Proof of Source of Funds
- One original bank reference letter issued by an internationally recognized bank, not older than 6 months.
- Original 12 months bank statements
- One original professional reference (e.g. from an attorney, notary public, chartered accountant or other professional of similar standing), not older than 6 months.
- One original Employment letter
- Original excerpt of marriage record or certified copy of marriage certificate(s) (if applicable).
- Certified copy of divorce document(s) (if applicable)

Timeline to Citizenship:

It generally takes upto 5 months for the entire process to materialize

Step 1 (1-2 Months)

Your passport will be pre-screened by us for government pre-approval. To begin your application, a professional fee down payment is required.
